Attachment 3

Details required for the opening of a bank account

Identification of ultimate beneficiary

The term ultimate beneficiary relates to the natural persons who are ultimate owners of the company that is opening the bank account. The documentation below is also required for all company directors that are not provided by recommended service provided and all bank signatories that are not provided by Ioannou, Theodoulou Ltd.

If the ultimate beneficiary is a company that is listed on a recognised stock exchange, then this documentation is not required.

- Certified copies of passports of ultimate beneficial owners Yes

- Two original utility bills or bank statements showing the name and address of each beneficial owner Yes

In cases where the company is owned by a trust, then the above documentation will be required in respect of each beneficiary of the trust. In addition a certified true copy of the trust deed is also required.

Identification of group structure

If the shareholder of the company is a body corporate which is in turn owned by other corporations and/or natural persons then a clear group structure is also required which should be provided to us. Under certain circumstances, certified copies of the statutory documents of one or all of the companies may also be required.

If a bank account is required to be opened with a non-Cypriot bank additional information and documentation may be required.

If the company opening a bank account is owned by another company which is registered in a country classed as a 'tax haven jurisdiction' by the OECD or which allows the issue of bearer shares then additional and documentation may be required.
